Tuition & Optional Fees

The following policies have been implemented to promote high-quality academic instruction and provide materials/supplies necessary to fulfill the increasing needs of our school. These policies also ensure that we attract well-trained and educated teachers that support the quality education you have come to expect at Aspen Park Montessori.

Application Fee

In order to reserve your child's place in the program and to cover the cost for registration and materials, a non-refundable enrollment fee of \$100.00 must be made at the time of submitting the Application Enrollment form. This payment is non-refundable and will be forfeited if the child does not attend our school.

Monthly Tuition

In order to provide a steady revenue that is necessary for effective budgeting and program stability, we require a 30-day notice of termination. Our tuition fees are used to provide quality care and an exceptional learning environment for your child. Tuition has been closely evaluated and is very competitive with other programs including Jeffco Public Schools. Tuition fees will be reviewed each September and if required, an automatic raise in tuition will go into effect.

The monthly flat-rate tuition fee for Fulltime 5-days is currently \$890 (regardless of the days your child attends). Starting September 1, 2020 tuition will increase to \$1,000/month. We have decided to only offer the 5-day option due to the COVID-19 pandemic. All other options including drop-ins are no longer available.

Prompt payment of tuition (1st of the month) is necessary to ensure that the center can maintain quality care and education. Tuition fees that are not paid in full by 3:30 p.m. on the sixth (6th) of the month are considered past due, and a charge of \$25.00 per day, including weekends, will be assessed to your account until fees are paid in full. If tuition fees are underpaid and/or overdue for two consecutive weeks, preschool will be suspended until full payment is received.

Sibling Discount

Families with more than one child enrolled for preschool will receive a \$50.00 discount off the tuition rate.

Tuition NSF Fee

The center needs to have an adequate cash flow in order to maintain the high standard of care provided. Therefore, a fee of \$75.00 will be charged for any check returned due to non-sufficient funds (NSF). In addition to the NSF fee, parents are responsible for all charges assessed due to NSF checks. NSF checks will be re-deposited once and if returned a second time, cash or money order payment is required for replacement of the check. If three separate checks are returned due to NSF all subsequent tuitions payments must be made in cash or money order.

Before & After Zone

Additional fees: Before Zone: (7:00-8:30am) \$150/month & After Zone: (3:30-5:30pm) \$200/month. At this time both zones have been suspended due to COVID-19.

Legal Fees

If it is necessary for Aspen Park Montessori to engage in legal action, parents/legal guardians are responsible for all costs and expenses, including attorney's fees, incurred in the collection of any fees due from their account, and/or defending any lawsuit brought by the family in which Aspen Park Montessori prevails. Such costs and expenses also include but are not limited to court costs, bank charges, and the cost of a substitute and/or additional teacher/aide to cover administrative time away from the center.
